Study course objective: The goal of studying the teaching content of this course is to enable students to obtain introductory knowledge about the state and law necessary for further study and general academic education.			
Study course outcome: Gaining knowledge about categorical legal apparatus as a condition for understanding other legal and social teaching subjects.			
Contents of the course			
<i>Lectures</i> Cover the following thematic areas: state and law as social phenomena; state as a community: concept, characteristics (territory, nation - citizens - nationality, national state); state power (sovereignty and legitimacy); state as an organization; state authorities: concept and types; forms of state: forms of rule (monarchy and republic), forms of political regime (democracy and autocracy), forms of state organization (simple, complex and regional state) and forms of state power (presidential, parliamentary and assembly system); the state of law and the rule of law; law: concept and types of social norms (moral, custom, law); legal order: legal norm (general - constitution, law, sub-legal act, act of autonomous subjects), judicial practice, jurisprudence, legal vacuum, individual legal act (complete and incomplete: legal work, administrative act and court act) legal relationship (authority - subjective right and, in particular, human right and jurisdiction); subjects of law (natural and legal persons), legality (and constitutionality, constitutionalism); legal system: concept, elements and types.			
<i>Practice classes</i> Extending knowledge from the legal field, getting acquainted with the most important legal acts of the state, analyzing them, reviewing the already presented learning contents and checking the knowledge through colloquiums.
